# Most Nebraska homes use around half their energy for heating and cooling.

This includes all energies such as electricity, natural gas, and propane. According to a Nebraska energy burden study, the average Nebraska household spends more than \$2,400 for the energy needed to run their home. What if you could reduce your heating and cooling needs by up to ten percent while helping to automate your home?

Check with your local electric utility for eligibility. - Confirm your home's HVAC system is compatible with the selected thermostat. Residential applicants only.
- Install the thermostat (professional installation is recommended) and ensure an operative Wi-Fi connection.
- Complete and submit incentive application with proof-of-purchase to your local electric utility. If professionally installed, submit copy of your contractor's invoice.

- Schedule setting
- Supporting utility demand-side management programs
